

Terms & Conditions for attending as seller / exhibitor at Travel News Market Sweden 2026

Travel News Market is a trade event organized by RES Travel Magazine Sweden AB, registered in Sweden as a Private Limited Company, with organisation number: 556813-5288.

1. Travel News Market offer a platform for information exchange and interaction between sellers and buyers, with the possibility for booking pre-scheduled meetings
2. Only registered sellers who have been accepted for attending the event shall be allowed to enter the platform and database for Travel News Market.
3. This registration is binding once it has been received by Travel News Market and the company is liable for paying the fee for attending based on the invoice that shall be issued. The fee includes full access to the database before, during and after the event, listing in the website, the database and promotional material, having a table during the event for one or two persons, having access to lists of all buyers and media attending, meal service and other functions during the event.
4. The cancellation policy is as follows:
 - 4.1 Registration fee is non-refundable.
 - 4.2 Cancellation made more than 60 days prior to the event, stand fee will be refunded with 100%.
 - 4.3 Cancellation made later than 60-31 days prior to the event, stand fee will be refunded with 80%.
 - 4.4 Cancellation made later than 30 days prior to the event, stand fee is non-refundable.
5. Travel News Market reserves the right to deny a supplier from attending, if this partner does not meet the criteria for the event, and therefore have limited chances for benefitting from attending. The partner will in such a case be contacted immediately and be informed about the reason for the rejection. Such refusal can also be due to the high number of companies already registered from the same country etc., mainly to secure the business of those companies attending. If a qualified seller can not be accepted due to the booking situation, the company shall be offered to be included in a waiting list for the event.
6. Travel News Market reserves the rights to cancel the event in case of unforeseen circumstances, or due to unacceptable low attendance that will harm the partners. Before an

event is cancelled, registered suppliers will be consulted as far as possible for their views. In the event of a cancellation, all registration fees paid will be refunded. No refunds will be made for any other costs incurred by suppliers or for any work carried out by them in connection with the event.

7. Travel News Market accepts no liability towards the supplier for possible low support or interest by attending buyers, or for the absence of possible key participants. It shall be underlined that the Travel News Market organizer provides a platform and arena for networking, while the booking of meetings is based on an interaction directly between sellers and buyers, although taking place in the database system being provided.

8. Travel News Market accepts no liability of any kind for possible errors in printed or electronic information materials concerning the event.

9. Both buyers and sellers can request meetings in the system, but the other party always has the right to approve or refuse a meeting request. All partners are requested to respond promptly to meeting requests.

10. Suppliers must comply with law and regulations, and acquire any and all permits required in connection with the event from the responsible authorities, if any such are relevant.

11. Only registered partners who have paid their invoice for the participation can attend the event, and they are only allowed to enter the venue when wearing appropriate name badges.

12. Any participants who do not follow the rules and guidelines for the event, or violate laws and regulations, can be banned from attending Travel News Market.

13. In particular, the sellers need to apply with the GDPR laws, which means that they need to have the permission to contact buyers through their personal email. However, any buyer etc. can of course be contacted through the system for Travel News Market, in order to request meetings.

14. All registered sellers agree to receive information from the Travel News Market organizer, both related to the event they are registered for, as well as invitations for future events. However, the contact information shall not be transferred to others or used for other purposes.

15. All registered participants are to be stored in the database for at least two years for future event information.

16. If requested, a person can be removed from the mailing list at any time by informing the organizer.

17. Terms of payment. Registration fee is invoiced and payable 30 days after registration.

Registration fee is obligatory and non-refundable.

Technical equipment and other services are payable 14 days before the opening of Travel News Market.

18. VAT 25% will be charged on all Swedish exhibitors

If the exhibitor is established outside Sweden but within the EU, a VAT number should be sent to the supplier for the exhibitor to receive an invoice without Swedish VAT and then reverse charge is applied. If the exhibitor is established outside the EU, a document showing that the exhibitor is having business activities in the country where the company is established should be sent to the supplier for the exhibitor to receive an invoice without Swedish VAT.

Payment after the due date implies a 2% interest on overdue payment per month. Cancellation of order does not imply cancellation of space rent.

19. Insurance. The exhibitor should be able to show valid insurance before attending the fair.

The insurance shall cover damages on people, property and the venue as well as the venue's property – caused by the exhibitor.

The exhibitor is responsible for all equipment and other property that the exhibitor is renting during Travel News Market or has brought along to the event.

The exhibitor is also responsible for damage, costs or enjoinderment from authority because of actions by the exhibitor.

The exhibitor pays all needed for restoring the space for the showcase, such as dismantling of the showcase, transportation et cetera, if not another solution is agreed on.
